- The scale and degree of caring they provide means that it would be impossible to replace all unpaid care with formal care services
- Caring can be a rewarding experience yet many face isolation, poverty, discrimination, ill-health, frustration and resentment as a result of their caring role
- Carers should be recognised for the valuable contribution they make and should be supported in their caring roles, in their health and well-being and in their wider aspirations

3. **ISSUES AND/OR OPTIONS:**

3.1 It is estimated that there are approximately 15,000 carers in Thurrock and yet there are currently only around 500 known to the Council (just 3.5% of the local carer population) and not all of these are receiving services. With a growing and ageing population, there is likely to be an increase in the demands upon carers who are already providing the bulk of care and are themselves becoming increasingly elderly.

It is clear that Thurrock Council will need to provide smarter and more focussed targeting of limited resources if it is to successfully support its care population in the future.

- 3.2 In response to these challenges, Adult Social Care, Children Education and Families, NHS South West Essex, South Essex Partnership NHS Foundation Trust (SEPT), Third Sector organisations and local carers have worked together to develop a draft Thurrock Carers Strategy that can respond to the increased need for services within financial constraints.
- 3.3 This strategy is currently in a draft format and will be subject to a formal public consultation period.
- 3.4 The strategy broadly follows the themes of the National Carers Strategy:

Carer Recognition, Assessment and Support

We want to have a clear and strong carer focus and have carer identification systems that are robust and allow for early intervention.

Information and Communication

We want to identify more carers and signpost carers to good quality information and support at the time that it is needed

Health and Well-Being

We want to help maintain the emotional and physical health and well-being of carers and their families

A Life of Your Own

We will support carers to have a life of their own through access to work and financial security, education and leisure

We will promote and participate in joint working between social care, housing, health, carers and Third Sector groups and any other stakeholders who have an impact upon carer's services in Thurrock. We will work closely with local GP's and the emerging Clinical Commissioning Groups to promote awareness of carers and their needs and to ensure that clinical commissioning decisions are taken with the requirements of carers in mind.

Partners in Care

We will ensure all services and service developments are carer-led and, where possible, are in line with what carers say they want and need.

Management Information Systems

The collection, recording and reporting of carer information will be improved in order that we may produce evidence of services provided and outcomes achieved and identify gaps in services and areas for development.

Young Carers

Children and young people will be protected from inappropriate caring and have the support they need to learn, develop and thrive, to enjoy positive childhoods and to achieve against the 'Every Child Matters' outcomes.

Equality

We will provide equitable services all carers can access. We will develop ways to find Thurrock's 'hidden' carers and explore culturally sensitive ways of enabling and encouraging people to access services.

3.5 Given that Thurrock is engaging with relatively few carers, it is recognised by all partners that the Support, Advice and Information element of the Carers Centre Service is not working effectively. The July 2011 Cabinet gave approval to enter into a tender process seeking an independent partner to deliver improvements in this area. This was following a 2011/12 Budget Consultation Exercise which determined that a third party partner should be identified through a procurement exercise.

4. **CONSULTATION** (including Overview and Scrutiny, if applicable)

4.1 The Carers Strategy will enter into a formal 3 month consultation period commencing in February 2012. Its development has been informed by a working group of professional and carer representatives.

The formal consultation will include, (but not be limited to), engagement via; face to face meetings, public events, attendance at carers events and web based feedback mechanisms.
