**Purpose of Report:** The Committee is asked to comment on the draft Market Position Statement for Adult Social Care, and to note the arrangements for consultation on the Statement.

### **EXECUTIVE SUMMARY**

The draft Care and Support Bill gives councils a new legal responsibility to promote a range of high quality services to meet the needs of the community. Councils are expected to carry out this new duty through their market shaping capacity, including preparing a Market Position Statement. This should set out current and future demand for, and supply of, care and support services, and the outcomes required, to assist local providers in meeting the needs of local people.

The draft Market Position Statement for Thurrock provides details of the market for adult social care services and how demand is expected to change in coming years. This will be further developed over the next few months in consultation with service users, carers and providers, and a final version will be presented to the Health and Well-being Board for approval in March 2014. The Market Position Statement will then set the direction for Commissioning Strategies for integrated adult social care and health care services to promote health and well-being in Thurrock.

### 1. **RECOMMENDATIONS**:

1.1 The Health and Well-Being Overview and Scrutiny Committee is asked to comment on the draft Market Position Statement for Adult Social Care.

# 1.2 The Health and Well-Being Overview and Scrutiny Committee is asked to note the consultation arrangements for the draft Market Position Statement for Adult Social Care.

### 2. INTRODUCTION AND BACKGROUND:

- 2.1 The draft Care and Support Bill gives councils a new legal responsibility to promote a range of high quality services that meet the needs of the community. The aim is to improve choice, provide tailored care, and focus interventions on the outcomes that matter to people.
- 2.2 In carrying out this new duty, councils are expected to prepare a Market Position Statement setting out current and future demand for adult social care services, and the outcomes required, so as to help local providers to respond and invest in their staff and service models.

### 3. The draft Market Position Statement for Adult Social Care in Thurrock

- 3.1 The draft Market Position Statement for Thurrock (attached as Appendix 1) provides details of the demand for and supply of adult social care services including those services jointly provided with Health. It also sets our how the need for adult social care may change over the next 5 years, and the plans to meet those needs. This includes initiatives under our Building Positive Futures programme to improve housing choices for older and disabled people, to strengthen communities and promote resilience, and to develop prevention and timely intervention services. It also highlights the intention to fully integrate adult social care and health care services in the coming years, and to support providers to train, retain and motivate their staff.
- 3.2 The draft Market Position Statement for Thurrock will be further developed over the next few months in conjunction with services users, carers and providers, and a final version will be presented to the Health and Well-being Board for approval in March 2014. A series of Commissioning Strategies will then be developed setting out in detail what investment in services and other initiatives is required to promote health and well-being, and to support older and disabled people, in Thurrock.

### 4. **REASONS FOR RECOMMENDATION:**

4.1 The Market Position Statement is intended to provide a picture of the demand for and supply of social care services, and the Health and Well-being Board's expectations about how those services need to develop and improve. It is intended to influence the choice, quality and quantity of services made available locally for service users and carers. When approved, it will also inform commissioning strategies and so the procurement of services. This draft version will form the basis of consultation with service users, carers and providers about how to improve the quality and choice of services locally, and the outcomes required to promote health and well-being in Thurrock.

### 5. CONSULTATION (including Overview and Scrutiny, if applicable)

- 5.1 The draft Market Position Statement will be subject to consultation before being finalised and presented to the Health and Well-being Board for approval in March 2014.
- 5.2 Consultation will be undertaken in conjunction with Thurrock Coalition and presentations will also be made to Partnership Boards and other service user and carer fora, as well as provider fora. A report on the outcome of the consultation will be presented to the Health and Well-being Board with the final version of the Market Position Statement.

## 6. IMPACT ON CORPORATE POLICIES, PRIORITIES, PERFORMANCE AND COMMUNITY IMPACT

- 6.1 The production of a Market Position Statement is part of the new and developing role of the local authority shaping the market rather than providing and managing services. As such it has a significant part to play in the transformation of the adult social care offer and in building a sustainable, integrated health and social care system.
- 6.2 The focus in the draft Market Position Statement on integration with health, and joint commissioning of preventative and personalised services, will lead to improvements in health and well-being as well as helping to reduce demand for services. The use of strength based approaches in both the assessment and commissioning processes, will ensure services assist residents to maintain their independence in their community, and to enable them to regain skills and confidence, while offering protection to those who are vulnerable.
- 6.3 The Market Position Statement is also relevant to the Council's role in relation to workforce development. As both a commissioner of services and through its wider influence on the market, including the provision of information and advice to users who fund their own services, the Council and its Health partners will wish to support providers to train and motivate their staff in innovative approaches to person centred care.
