She remarked that Members of the Sub-Committee had read the report and heard submissions from both Licensing Officers and the Applicant and it was therefore for the Sub-Committee to decide whether there was good reasons to depart from the policy and to deem the vehicle suitable to be licenced as a Hackney Carriage vehicle.

The Sub-Committee adjourned at 8.01pm for deliberation and were accompanied by the Legal Advisor and the Democratic Services Officer.
