The Licensing Officer provided a short summary to the Sub-Committee and in doing so advised the applicant did not meet the Licensing criteria under Thurrock Council's pre licensing standards regarding providing satisfactory Criminal Record checks. She continued by explaining Under Section 51 (1)a, Local Government (Miscellaneous Provisions) Act 1976, the council shall not grant a licence unless they are satisfied the application is a fit and proper person to hold such a licence, it was therefore for the Sub-Committee to decide whether the applicant was a fit and proper person to hold a Hackney Carriage Driver's licence.

The applicant was asked to present a summary of his case to Members; during which during which he stated he wished to work or Thurrock as he was living in the area and working for TFL, the office took 25% of his earnings.

The Chair asked if there were any further questions, there were none.

The Sub-Committee adjourned at 8.00pm for deliberation and were accompanied by the Legal Advisor and the Democratic Services Officer.
