Purpose of Report: To report on the latest draft version the Pupil place Plan (2020-2024) and bring to the attention of the Committee the latest forecast of pupil place requirements.

Executive Summary

Thurrock Council has undertaken its annual review of pupil places and has published the revised Pupil Place Plan (PPP) 2020 to 2024 version, which can be viewed on the Thurrock Council website.

The Pupil Place Plan gives information about the supply of school places in Thurrock and forecasts pupil numbers for the next five years, setting the context of the provision of school places in Thurrock.

The Pupil Place Plan is consulted on each year with all schools and the Schools Forum. This provides a forecasted picture of pupil place planning across Thurrock and helps to identify where we are likely to see capacity issues.

1. Recommendation

- 1.1 Overview and Scrutiny Committee is asked to review the PPP recognising the additional schools places that will be required going forward.
- 2. Introduction and Background:

- 2.1 The Council has a statutory duty to provide a school place for every child living in its area of responsibility, who is of school age and whose parents want their child educated in a Thurrock school.
- 2.2 To aid meeting this statutory duty, the Council undertakes and annual review of the PPP. This document is used by a range of partner's school sponsors and developers of new dwellings.
- 2.3 As population demographics are dynamic, it is necessary to continually review and update pupil place forecasts. Pupil place requirements are reviewed several times during the year.
- 2.4 The latest draft PPP for the period 2020 to 2024 is attached for review. The PPP gives information about the supply of school places in Thurrock and forecasts pupil numbers for the next five years, with information on the changing context within which planning takes place.

3. Issues, Options and Analysis of Options

- 3.1 The context within which the Council is required to plan school places is becoming increasingly complex and Thurrock has robust processes in place. A PPP team is in place that meets every 4 weeks and is made up of officers from the PPP team, Finance, Admissions, Awards & Benefits, Transport, Early Years and School Improvement to review current positions, issues and forecasts.
- 3.2 Academies are able to increase their pupil numbers without agreement from the Council within agreed limits.
- 3.3 The birth rate in Thurrock is increasing with the number of live births in 2015/16 being the highest that Thurrock has ever had. Thurrock's population has become more mobile therefore making projections more difficult to manage and forecast. During the last few years the Council has experienced a significant increase in the number of in year applications from families moving into the area.
- 3.4 The School Capital Team work closely with schools and academies in accommodating these large increases by carrying out expansion or adding bulge classes where the need is identified.
- 3.5 Thurrock is made up of a number of planning areas, five for the primary sector: Aveley Ockendon and Purfleet, Grays, Tilbury, Corringham and Stanford-Le-Hope and the Rural area. There are three in the secondary sector: West, Central and East, these larger planning areas provide more flexibility when considering pupil placement.
- 3.6 Thurrock has been successful in free school bids of which there are two new secondary schools, Thames Park and Orsett Heath who opened their doors to new students in September 2020 at their temporary sites. Both schools are on track to open on their permanent sites in September 2022. A new special

free school, Treetops 2, which will provide much needed special school provision which is planned to open in September 2021.

- 3.7 The primary phase forecasts in the 5 year plan are calculated on the basis of known data regarding live births in Thurrock, the number of children already on roll in schools and the anticipated child yield from proposed housing developments in the planning system.
- 3.8 Of the in-year school admissions applications that was processed from September 2019 to August 2020, 36% arrived in Thurrock from other parts of the country and as well as arriving into the UK.
- 3.9 There is currently surplus capacity in the secondary phase following the opening of the two new free schools in temporary accommodation. We anticipate that the surplus capacity in secondary schools will be required going forward as the increased primary population moves through the system.
- 3.10 Due to an increased number of families moving to Thurrock we have needed to open bulge classes this September in Grays, Aveley, Ockendon and Purfleet planning areas to support the large increase in demand for primary school places.
- 3.11 Based on PPP forecasts and having reviewed the current school place vacancies we have identified there is a need to create additional school places in the following planning areas:
 - Tilbury
 - Corringham and Stanford
 - Aveley, Ockendon and Purfleet
- 3.12 As part of the Council's drive to ensure a strategic and proactive approach to pupil place planning regular monitoring is taking place with regular updates on position provided at Schools Forum and Headteachers termly briefings as well as consultation with schools in planning areas where there is a need for additional school places.

4. Reasons for Recommendation:

4.1 To ensure that the Council discharges its duties to secure sufficient schools in its area and to consider the need to secure provision for children with SEND.

5. Consultation (including Overview and Scrutiny, if applicable)

5.1 The Pupil Place Plan was sent to maintained schools and academies for consultation.

6. Impact on Corporate Polices, Priorities, Performance and Community Impact

School places are funded through allocations of the Dedicated Schools Grant, which is linked to the number of pupils within school, although it is lagged by one year, so significant growth can put some short term pressure on School Budgets.

The Capital costs of providing the infrastructure to provide more School places are generally funded through Basic Needs Capital Grants. These costs would be detailed within the Schools Capital Programme.



INTRODUCTION

Thurrock has some very exciting regeneration programmes and we are committed to ensuring that we have high quality educational opportunities for our children and young people.

Our Pupil Place Planning (PPP) document has been widely used by stakeholders such as developers, and educational providers. The forecasts contained in this document are also used to inform the schools' capital programme and to date we have delivered a range of high quality projects that contributes to ensuring the delivery of good educational outcomes for the children and young people of Thurrock.

Two new Secondary Free Schools are opening in September 2020 in temporary sites with an initial Published Admissions Number of 120 pupils per school. This will affect the Secondary Year 7 forecast published in this booklet but will not be included in these figures until next year as this booklet is based on the Autumn 2019 census.

A new special free school, Treetops 2 will be delivered in Thurrock, and is due to open in September 2022.

There are plans for a new 2-form entry primary free school, located in Aveley planned to be delivered in the near future.

This data has allowed us to review trend data on pupil numbers which helps with future forecasting, we currently have 17,196 Primary Pupils and 10,173 Secondary Pupils. Thurrock continues to be a place of choice for families wishing to move into the area and this can be seen from the numbers of children and young people requiring a school place.

Thurrock has strong working relationships with our schools and academies and this allows us to work in partnership with them when identifying locations where we can build in additional capacity for additional places. The Council is committed to ensuring that we have clear processes in the decision making around meeting local demand for school places.

We hope that this document continues to be of interest to all stakeholders and that the content is both useful and clear.

PUPIL PLACE PLANNING (PPP)

Over the last 7 years we have continued to see an increase in the primary population. The 2015/16 birth data is still the highest Thurrock has had at 2,505 with the two years either side of that just fractionally below the 2,500 and the current Year 3 is the highest cohort we have had at 2,545. The last three years average of birth data is 2,470). After reaching a peak of 2,505 births in 2015/16 we are now seeing a slight decline. Our primary cohort average is now 2,456 per year group, 2 new Secondary Free Schools should ease the pressure on secondary places as the primary cohort moves through. Thurrock is also getting a new Special Free School. The PPP document covers education for children in the age range of 4 - 16. Post 16 provision information is contained in Annex 4.

Special Educational Needs and Disability (SEND) educational provision and Early Years and Childcare provision are undertaken by other specialist areas within Thurrock Council and are not covered in this document.

Thurrock Council has a statutory responsibility to provide a school place for every child of school age who live in Thurrock. PPP is very complicated to predict with many factors dictating the outcome. Planning for school places begins with the acquisition of birth data which identifies the number of children that are born and the post code they live in and it is assumed that 4 years later they will enter the school system in a local school. There are a number of factors that are forever changing and need to be considered. In-year admissions, where children come into Thurrock mid–year (outside the normal admission rounds) are very difficult to foresee and project. Numbers of children that have moved into Thurrock from elsewhere in the country and those that have moved in from other countries can be seen in Annex 1.

Thurrock's forecasting for school places to date has been robust and accurate. The difficulty with forecasting is that although forecasts are accurate we are not able to identify how old the children will be that move into Thurrock and to what year group they will be applying for. This takes close monitoring and we need to be in a position at times to take swift action in opening up classes within certain year groups. Every effort is made to seek and offer a school place within reasonable travelling distance from the pupil's home.

Thurrock calculates the pupil yield from housing developments and then adds this to the projected pupil numbers. Thurrock currently does not project any child yield from a one bedroomed flat but the current economic climate suggest that this is now not so. Families moving in with other families make projecting pupil numbers now more difficult to predict the demand at local school level.

We are committed to ensuring that parental choice and an environment built on strong partnership foundations provides healthy competition across both primary, secondary and post 16 provision.

CONTEXT

Under the banner **People**, **Place**, **Prosperity**, Thurrock Council is creating a place where people and businesses want to stay and thrive and developers and investors want to invest.

Investment in infrastructure for the benefit of residents and local businesses is key. Good roads, health services, schools and leisure facilities are all required to enable people to work and play, live and stay in the borough.

Situated on the north side of the River Thames bordering Essex, Kent and East London, Thurrock is an area of great contrast and unique opportunities and is a crucial strategic player in the South East Local Enterprise Partnership, South Essex 2050 partnership and the Thames Estuary plans.

Thurrock has a well-balanced mix of beauty and business with £20 billion investment planned for homes, jobs and infrastructure, including £6 billion being invested in private sector jobs.

Rural villages and market towns are set into the 70% of the borough which is green belt. Nature reserves, heritage locations and sites of special scientific interest abound.

Three international ports punctuate 18 miles of riverfront with cranes and gigantic container ships, while industrial parks line the A13, all within driving distance of the major London airports. Indeed, Thurrock is probably more important strategically to London than the London boroughs themselves as through our ports the capital is fed, fuelled and clothed.

There has been a lot of talk about plans in the past but there is now a step-change to actual delivery – some master plans are agreed, with contractors on-site and work is beginning.

Thurrock has a growing population – predicted to rise by approximately 10% every decade. The ethnic profile of Thurrock has become increasing diverse over the last decade. Both the age and ethnic profiles change significantly between the 20 wards.

Together with partners, Thurrock Council is investing more than £70 million to create over 350 new school places across the borough in the coming years.

We are working towards a future where every resident has a job -24,500 new jobs are planned over 20 years - with better educated children and skilled residents who can access local and national employment opportunities.

There are plans for four Integrated Medical Centres in the borough. This is just one of a series of game-changing initiatives being delivered with our health partners.

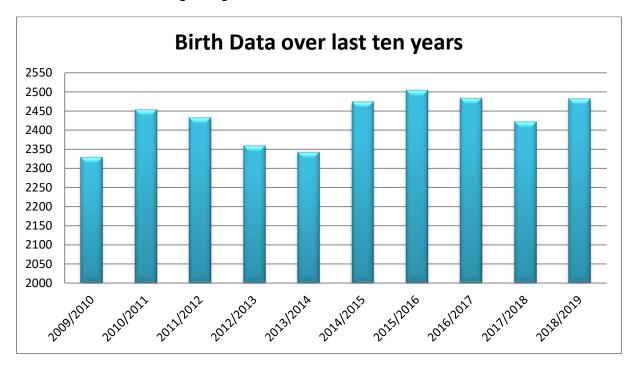
Thurrock is a place with a rich cultural heritage, which is often overlooked. With our cultural partners we are developing plans to enable all Thurrock residents to enjoy and benefit from high quality arts and heritage activity, creating a strong pride in place, better well-being and economic prosperity.



The table below demonstrates the conversion of live births in Thurrock to the actual take up of school places. This is showing a slight increase in reception numbers. This data enables Thurrock to project the place requirements for future years using the birth data available.

There are currently 39 Primary schools, 11 Secondary schools and 2 Special Schools in Thurrock.

Full details of the schools and the oversubscription criteria applied to each one is available within the Council's School Admissions Primary and Secondary Booklets which can be found at https://www.thurrock.gov.uk/school-admissions. These booklets contain information on how to make an application for a school place.

Each Academy, Free School and Voluntary Aided-School is its own Admissions Authority. The Council is the Admissions Authority for Community Schools and Voluntary Controlled Schools. In respect of Voluntary Aided Schools the governing body of the school determines admission arrangements. For Academies and Free Schools, the relevant Academy Trust is the Admission Authority. Each individual Admissions Authority applies its own oversubscription criteria to applications and determines which applicants to offer places to.

Applications for Thurrock Schools are made via the co-ordinated admissions process which is administered by the Council.

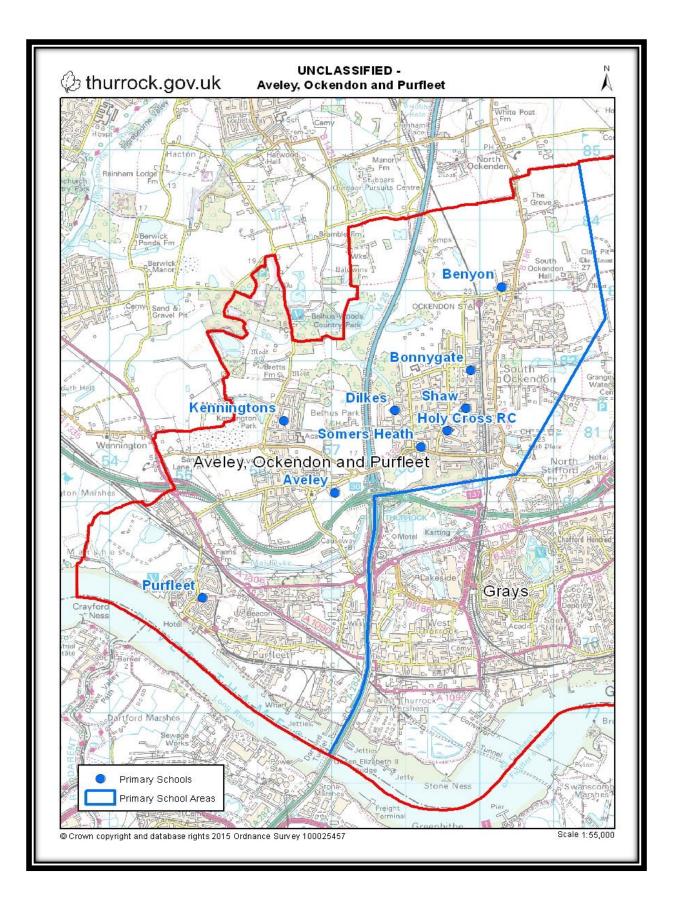
PRIMARY FORECASTS

Pupil place projections for each of the planning areas are set out in the following pages.

Reception intake September 2019 was the first year of our highest birth rate, therefore it is predicted that the next three years will show an increase in a reception intake and subsequent year groups.

The whole school projections for each primary school planning area have been calculated using birth data which in recent years was showing an increase five years later when pupils reach school age. These are projected to calculate reception numbers along with the actual number of children on roll in the schools in the October 2019 census, adding the pupil yield from housing developments and then adding an additional element of places to cater for in-year admissions. This degree of additional places is required to enable schools to absorb the number of pupils we anticipate will arrive in Thurrock from elsewhere in the UK and abroad in the September 2020/21 academic year and beyond. The impact of inward migration will be closely monitored and forecasts adjusted accordingly.

Full details of the methodology used to determine the pupil place forecasts for the primary phase are set out in Annex 1.

Primary Forecast Summary

Reception intake September 2019 will be the first year of our highest birth rate, therefore it is predicted that the next 3 years will show an increase in a reception intake and subsequent year groups.

The pressure in the primary phase is being managed and will continue to be regularly monitored closely. The inward migration experienced in recent years had a more significant impact on primary places than secondary places. This may have been because we had capacity in our secondary schools which could absorb the newcomers or it may be that the families arriving in Thurrock had younger children.

Thurrock Primary whole school numbers have increased by 20% since Autumn 2012 which equates to a 2,908 pupil increase. However, the autumn school census for October 2018 and 2019 is showing a significant decrease in the amount of extra primary pupils when compared to the last five years.




SECONDARY FORECASTS

The primary increase is becoming noticeable when pupils are moving into Year 7 and beyond.

Whole school forecasts for each secondary planning area has been calculated using formulae to calculate the transition rate from year 6 to year 7 and the current numbers on roll in schools on the census data from October 2019 and by also adding the pupil yield from any developments and then adding an additional element of places to cater for inyear admissions. This degree of additional places is required to enable schools to absorb the number of pupils we anticipate will arrive in Thurrock from elsewhere in the UK and abroad in the September 2020/21 academic year and beyond. The impact of inward migration will be closely monitored and forecasts adjusted accordingly.

Full details of the methodology used to determine the pupil place forecasts for the secondary phase are set out in Annex 1.

Thames Park Free School and Orsett Heath Free School will open in September 2020. Each school will open to 120 pupils at each site. These sites are temporary whilst their new permanent sites are under construction. This will affect the Secondary year 7 forecast and those pupil admission numbers will not be included until next year's Pupil Place Plan.





Secondary Forecast Summary

With the number of primary pupils moving into the secondary sector the demand for secondary places is increasing and will continue to do so over the next few years.

Two new Free Schools will open in temporary accommodation from September 2020 with initially a total of 240 places across both schools.



COUNCIL WIDE ISSUES

The two main factors for pupil increases in both the primary and secondary phases are the increase in birth rate and the amount of in-year applications. The table below details the increases of in-year applications outside the normal admission rounds.

Planning for the children arriving in Thurrock is difficult as we do not know who they are, how old they are, and therefore, which year groups they will apply for until they make contact with School Admissions. Some may require Reception and Year 7 places, but many will require places in other year groups. This introduces the potential of bulge classes in year groups other than Reception and Year 7 as we have experienced in recent years.

With the unpredictable demand for places from outside of Thurrock an additional element of pupil places has been added to each planning area within Thurrock.

ANNEX 1: PUPIL PLACE FORECASTING METHODOLOGY

The statutory obligation for all local Councils is to provide sufficient school places. Thurrock Council regularly reviews all data, trends and builds a robust analysis of pupil planning to ensure a place for all pupils that live in Thurrock either at normal admission rounds or the unforeseen "in-year" admissions.

Thurrock experiences high levels of in-year applications which has put pressure on school places but with the excellent relationships we have with our Schools and Academies, Thurrock Council has been able to continue to meet this demand.

Primary Forecasts

Thurrock Council uses live birth data provided by the National Health Service which forms the basis of calculating the place requirements four years later. This data contains post codes where the child lives which are then allocated to the nearest school in that area to calculate places required in that schools planning area.

Whole school forecasts are based on pupil census data; this provides actual pupil numbers in each year group. The number of children calculated from any building development is added to this to then calculate the number of school places required. An element of additional places is then added to cater for in-year admissions.

The building developments which produce over 20 pupils are taken into consideration in this edition of the PPP document and are listed under each planning area.

There is a project team made up of officers from various departments within the Council that play a part in PPP that meet monthly to review forecasts and any emerging issues. This allows the Council to be proactive in taking any necessary action to meet growing pressures for school places.

Secondary Forecasts

With the high level of primary school places we have we know that these will feed through to our secondary schools. When calculating year 7 forecasts we use existing primary numbers. Using trend data we have used a transfer rate of 92%, meaning 8% of our children go outside of the Thurrock area. Thurrock has no secondary provision for Catholic boys who tend to move out of the area to attend a Catholic secondary school.

The Year 7 forecasts in this document were arrived at by examining the conversion rate from Year 6 to Year 7 for the last three years. This is the number of Thurrock Year 6 pupils who went on to become Year 7 students.

Having established the predicted number of Year 7 students for each school, we then address the child yield from housing developments.



We know the predicted number of children in each area that are likely to arise from developments but we cannot know how old they will be or which year group they will require. We therefore assume that some of the children generated by new developments will require primary places and some secondary places.

A number of places are therefore added to the whole school predictions for both primary and secondary at the schools in the areas where the development is due to take place. If a major development falls between two or more schools the child yield is divided between the schools.

Migration

Thurrock is still experiencing increases in the number of children applying for a school place "In Year". These arrivals during the academic year are difficult to manage as we do not know how many of each age group will arrive. The extent of inward migration in recent years indicates that 5% of school places are required in the primary phase and 3% are required in the secondary phase to ensure that the new arrivals can be accommodated.

The forecasts are not constrained by the physical accommodation available in the schools in the planning area and therefore indicate where pressure on places is likely to arise.

Pupil Migration

Thurrock is a net exporter of pupils. The numbers both in and out of Thurrock for receptions and year 7 are listed below. The percentages listed are comparing these numbers against September 2019 actual on time applications numbers for reception and Year 7. These numbers only relate to the normal admission round.



Primary

17 children are expected to come in to the LA +.5% by September 2020

77 children expected to go outside of the LA -3% by September 2020

Secondary

51 children are expected to come in to the LA +2.3% by September 2020

251 children are expected to go outside of the LA - 10.2% by September 2020

ANNEX 2: SPECIAL EDUCATIONAL NEEDS AND DISABILITY (SEND)

An education, health and care (EHC) plan is for children and young people aged up to 25 who need more support than is available through special educational needs support.

EHC plans identify educational, health and social needs and set out the additional support to meet those needs.

The Council has two special schools in the borough

Beacon Hill Academy is a special school in South Ockendon for pupils who have severe and complex learning difficulties. Beacon Hill Post 16 provision caters for students with severe and profound and multiple learning difficulties from 16 to 19. This provision is located on the shared site with Treetops School in Grays. Students follow a personalised, accredited curriculum which promotes independence and transition to lifelong learning in the community.

Treetops School is a day special school academy in Grays for pupils between the ages of 3 and 19. The school caters for children and young people with moderate learning difficulties and Autism.

A new Special Free School has been agreed by the Education Funding Agency and is in development. The school will be located on a site adjacent to the existing Treetops School. The new Treetops Academy is planned to open in the academic year 2021/22.

The numbers of commissioned places in the Special Schools and Resource Bases are agreed between the Council and the schools on an annual basis. There is potential opportunity for additional places to be commissioned by the local authority as required and where possible during the academic year.

ANNEX 3: PROVISION FOR PUPILS OUT OF SCHOOL

Thurrock has developed two new Primary Inclusion Bases for pupils who have been permanently excluded or are at risk of permanent exclusion to provide direct support for these pupils and to support their re-integration into mainstream school. The two Inclusion Bases are at East Tilbury Primary School and Thameside Primary School, both of which are Primary Academies part of the Osborne Multi Academy Trust.

The Olive Alternative Provision Academy based in Tilbury provides a secondary offer for pupils because of exclusion, illness or other reasons, would not otherwise receive a suitable education. The service provides a range of different interventions to support young people to reengage with mainstream provision.

Admission to the service is by referral only. All referrals are made via the Council's Access and Inclusion Service.

ANNEX 4: POST 16 PROVISION

The 2008 Education Act raised the age of participation for young people in England. Those born on or after 1st September 1997 must remain in some form of education or training until their 18th birthday. This may be:

- full time education at school or college,
- an apprenticeship or traineeship,
- part-time education or training as well as being employed, self-employed or volunteering for 20 hours per week or more.

Thurrock Council works closely in partnership with schools and colleges and other providers to plan provision for post 16 education and training. Young people can pursue a wide range of both academic and vocational courses in a range of settings.

Five secondary schools in Thurrock currently offer post 16 education; Gable Hall, Hassenbrook and St Clere's schools form the Stanford and Corringham 6th Form consortium and between them provide a range of academic and vocational courses.

Harris Academy Ockendon Studio School and 6th form is a 14 to 19 school offering a range of academic qualifications in addition to work based training. Applications for work based training places in the Studio School should be made via the Council's school admissions team. There are currently 75 places in the Studio School.

Harris Academy Chafford Hundred and Harris Riverside offers a 6th form provision which has a range of academic and vocational opportunities for young people, information on all the courses is available via the schools website.



Executive Summary

The council's school capital programme is developed following extensive pupil place planning to assess likely demand. The new programme aims to deliver sufficient pupil places for 2020 and 2021 academic years.

The new Pupil Place Plan 2020-2024 has now been published. The pupil place plan identifies sufficiency concerns in primary schools in the Tilbury planning area, Stanford and Corringham planning area and Aveley, Ockendon and Purfleet Planning areas.

This report seeks feedback from O&S before submitting to cabinet for approval to progress the school capital programme 20/21. The report seeks the views from O&S to build capacity in the planning areas where there is a current and forecasted need to provide additional primary school places.

This report additionally provides an update highlighting projects managed by Thurrock Council which form part of the current school capital programme emphasising the considerable and continued progress that has been achieved since the last report to Cabinet in March 2019.

This report also provides an update of the provision of temporary accommodation to ensure sufficient pupil places were available for September 2020.

1. Recommendation(s)

- 1.1 That O&S support the recommendation to Cabinet that a provisional School Capital Programme budget of £8 million as set out in this report be approved.
- 1.2 That O&S support the recommendation to Cabinet to approve the commencement of the procurement process in accordance with Council & EU procurement procedures to appoint Architect led multi discipline designers and Project Teams, for the next School Capital Programme and appoint the Principal Contractors to take forward the proposed schemes.

2. Introduction and Background

- 2.1 The local authority has a statutory responsibility to ensure that suitable and sufficient places are available in Thurrock for every child of school age whose parents wish them to have one.
- 2.2 The 2019/20 school capital programme has, despite the unique and challenging conditions progressed well and incorporated innovative partnership working, as well as utilising both traditional as well as modern methods of construction to deliver the identified additional pupil places required.
- 2.3 The provision of additional accommodation to meet the predicted increase in pupil numbers has generated positive feedback from schools, particularly in relation to the impact on learning through improvements to the built environment.
- 2.4 The demand for pupil places has increased significantly, over the last few months we have seen a large increase in 'in year' admissions from families moving into the Authority. Between September 2019 and August 2020 we received school applications and offered schools places for 190 children that moved into Thurrock from outside of the UK, and 1063 that moved to Thurrock from elsewhere within the UK. In order to deal with demand for this September we have created bulge reception classes of 30 children in our primary schools in both the Grays planning area and the Ockendon planning area. We are still seeing pressure in the some planning areas and will need to create additional school places following further in-year primary school applications.
- 2.5 Despite the relatively recent expansion of Graham James Primary School in 2015 which created an additional 210 places within the Corringham area of the borough, as well as 52 additional nursery places, following the annual review of forecasts for pupil places and the large increase being experienced with regards in-year admissions there is now educational need for further primary school and nursery places in the Corringham area.
- 2.6 At the time of writing, a feasibility study has commenced at Abbots Hall Primary School to identify the scope of works required in order to return the

school to a 2 form entry school, with a view to addressing the predicted shortage of places from September 2022 onwards in the planning area.

- 2.7 Following completion of this scoping and feasibility study, the proposal upon Abbots Hall Primary will be to refurbish and possibly remodel some of the areas of the existing building to ensure it is fit for purpose and meeting Department for Education building guidelines, as well as repurpose the nursery area in order to provide 6 classrooms, and new nursery. The school is in the process of submitting a Condition Improvement Fund (CIF) bid in order to relocate the nursery to an alternative location within the school. The nursery that is already onsite is operating within the school building. An estimated budget of £2M is required to cover both an architect led multidisciplinary design team responsible for providing specialist services needed to oversee the detailed and technical design for the expansion project, and a Principal Building Contractor for its construction phase.
- 2.8 In addition to the works at Abbots Hall a further budget of £6m is required to provide addition school places in the Tilbury Planning area and the Aveley, Ockendon and Purfleet planning area to meet existing and future demand. Options for additional provision is in the process of being identified.
- 2.9 JCT consultancy agreements and JCT Building contracts competitively procured and evaluated on both quality and price will provide opportunities for improving quality and value for money. It will give the Council the flexibility to award individual elements of construction projects on an individual basis without any guarantee of future work. This approach will result in a greater level of control being retained within the authority, and will not tie the council into any single provider.
- 2.10 In advance of these procurements, small value individual contracts are being utilised for the carrying out of topographical surveys, transport assessments, and environmental impact assessments.
- 2.11 Update on the current school capital programme

The 2019/19 & 2019/2020 school capital programme consisted of 6 No. projects in Thurrock primary schools. This extensive programme is now reaching its conclusion, with only works at Corringham Primary (new nursery and early years wrap around provision), St Clere's Secondary School (10 classroom expansion in addition to a 4 court sports hall), and Benyon Primary School (1FE 6 classroom expansion scheme) in progress at the time of writing this report, all of which are due to complete before the end of this calendar year.

2.12 Update on temporary accommodation

Works to convert the former Thurrock Learning Campus building into a temporary secondary school on behalf of Thames Park were fast tracked with all works being undertaken during the period of National lockdown.

Internally, the extensive remodelling was completed by early August 2020, with the external groundworks to provide an outdoor recreation space and sports ball court completed early September 2020. This building is anticipated to remain in use by Thames Park Academy for approximately two years while the permanent building is under construction.

- 2.13 Temporary accommodation was also completed at Orsett Heath Academy and opened to new pupils in September. The pupil will remain in this building for approximately two years whilst the permanent building is constructed.
- 2.14 In order to meet demand for places, from September 2019 Treetops school has had a double demountable classroom placed upon its site. This demountable is expected to remain for a further year while the new free school is under construction.

3. Issues Options and Analysis of Options

- 3.1 If the local authority does not undertake the school expansions and builds, the local authority will not be able to fulfil its statutory responsibility to ensure that there are sufficient places available in Thurrock for every child of school age.
- 3.2 The contract, due to its potential value over the threshold.

4. Reasons for Recommendation

4.1 Funding to the value of £8 Million as outlined in this report is requested in order to take forward the expansion programme and deliver required pupil places from September 2021 and meet the council's statutory duty.

5. Consultation (including Overview and Scrutiny, if applicable)

- 5.1. This report is to be considered by the Children's Overview and Scrutiny Committee.
- 5.2. The principle has been agreed with schools and any detailed build content will be agreed with the relevant schools. Consultation will continue with each school and key stakeholder, as each scheme and schedule of works evolves within the programme.

6. Impact on corporate policies, priorities, performance and community impact

- 6.1 If the local authority does not undertake the school expansions and builds, the local authority will not be able to fulfil its statutory responsibility to ensure that there are sufficient places available in Thurrock for every child of school age.
- 6.2 The award of these JCT Construction and design contracts will enable the Council to continue to meet its statutory duty under the Education Act 2006.

6.3 The issues in this paper support the council's vision to be an ambitious and collaborative community which is proud of its heritage and excited by its diverse opportunities and future. It also supports the prosperity priority - a borough which enables everyone to achieve their aspirations.

7. Implications

7.1 Financial

Additional accommodation required to meet the statutory requirement to provide places for the increasing pupil numbers will be funded from a combination of the DfE capital basic needs grant, Section 106 monies held for Education provision. Once in-depth feasibility studies have been completed, funding requirements will be quantified and confirmed.

There is sufficient funds available within the basic need grant.



INTRODUCTION

Thurrock has some very exciting regeneration programmes and we are committed to ensuring that we have high quality educational opportunities for our children and young people.

Our Pupil Place Planning (PPP) document has been widely used by stakeholders such as developers, and educational providers. The forecasts contained in this document are also used to inform the schools' capital programme and to date we have delivered a range of high quality projects that contributes to ensuring the delivery of good educational outcomes for the children and young people of Thurrock.

Two new Secondary Free Schools are opening in September 2020 in temporary sites with an initial Published Admissions Number of 120 pupils per school. This will affect the Secondary Year 7 forecast published in this booklet but will not be included in these figures until next year as this booklet is based on the Autumn 2019 census.

A new special free school, Treetops 2 will be delivered in Thurrock, and is due to open in September 2022.

There are plans for a new 2-form entry primary free school, located in Aveley planned to be delivered in the near future.

This data has allowed us to review trend data on pupil numbers which helps with future forecasting, we currently have 17,196 Primary Pupils and 10,173 Secondary Pupils. Thurrock continues to be a place of choice for families wishing to move into the area and this can be seen from the numbers of children and young people requiring a school place.

Thurrock has strong working relationships with our schools and academies and this allows us to work in partnership with them when identifying locations where we can build in additional capacity for additional places. The Council is committed to ensuring that we have clear processes in the decision making around meeting local demand for school places.

PUPIL PLACE PLANNING (PPP)

Over the last 7 years we have continued to see an increase in the primary population. The 2015/16 birth data is still the highest Thurrock has had at 2,505 with the two years either side of that just fractionally below the 2,500 and the current Year 3 is the highest cohort we have had at 2,545. The last three years average of birth data is 2,470). After reaching a peak of 2,505 births in 2015/16 we are now seeing a slight decline. Our primary cohort average is now 2,456 per year group, 2 new Secondary Free Schools should ease the pressure on secondary places as the primary cohort moves through. Thurrock is also getting a new Special Free School. The PPP document covers education for children in the age range of 4 - 16. Post 16 provision information is contained in Annex 4.

Special Educational Needs and Disability (SEND) educational provision and Early Years and Childcare provision are undertaken by other specialist areas within Thurrock Council and are not covered in this document.

Thurrock Council has a statutory responsibility to provide a school place for every child of school age who live in Thurrock. PPP is very complicated to predict with many factors dictating the outcome. Planning for school places begins with the acquisition of birth data which identifies the number of children that are born and the post code they live in and it is assumed that 4 years later they will enter the school system in a local school. There are a number of factors that are forever changing and need to be considered. In-year admissions, where children come into Thurrock mid–year (outside the normal admission rounds) are very difficult to foresee and project. Numbers of children that have moved into Thurrock from elsewhere in the country and those that have moved in from other countries can be seen in Annex 1.

Thurrock's forecasting for school places to date has been robust and accurate. The difficulty with forecasting is that although forecasts are accurate we are not able to identify how old the children will be that move into Thurrock and to what year group they will be applying for. This takes close monitoring and we need to be in a position at times to take swift action in opening up classes within certain year groups. Every effort is made to seek and offer a school place within reasonable travelling distance from the pupil's home.

Thurrock calculates the pupil yield from housing developments and then adds this to the projected pupil numbers. Thurrock currently does not project any child yield from a one bedroomed flat but the current economic climate suggest that this is now not so. Families moving in with other families make projecting pupil numbers now more difficult to predict the demand at local school level.

We are committed to ensuring that parental choice and an environment built on strong partnership foundations provides healthy competition across both primary, secondary and post 16 provision.

CONTEXT

Under the banner **People**, **Place**, **Prosperity**, Thurrock Council is creating a place where people and businesses want to stay and thrive and developers and investors want to invest.

Investment in infrastructure for the benefit of residents and local businesses is key. Good roads, health services, schools and leisure facilities are all required to enable people to work and play, live and stay in the borough.

Situated on the north side of the River Thames bordering Essex, Kent and East London, Thurrock is an area of great contrast and unique opportunities and is a crucial strategic player in the South East Local Enterprise Partnership, South Essex 2050 partnership and the Thames Estuary plans.

Thurrock has a well-balanced mix of beauty and business with £20 billion investment planned for homes, jobs and infrastructure, including £6 billion being invested in private sector jobs.

Rural villages and market towns are set into the 70% of the borough which is green belt. Nature reserves, heritage locations and sites of special scientific interest abound.

Three international ports punctuate 18 miles of riverfront with cranes and gigantic container ships, while industrial parks line the A13, all within driving distance of the major London airports. Indeed, Thurrock is probably more important strategically to London than the London boroughs themselves as through our ports the capital is fed, fuelled and clothed.

There has been a lot of talk about plans in the past but there is now a step-change to actual delivery – some master plans are agreed, with contractors on-site and work is beginning.

Thurrock has a growing population – predicted to rise by approximately 10% every decade. The ethnic profile of Thurrock has become increasing diverse over the last decade. Both the age and ethnic profiles change significantly between the 20 wards.

Together with partners, Thurrock Council is investing more than £70 million to create over 350 new school places across the borough in the coming years.

We are working towards a future where every resident has a job -24,500 new jobs are planned over 20 years - with better educated children and skilled residents who can access local and national employment opportunities.

There are plans for four Integrated Medical Centres in the borough. This is just one of a series of game-changing initiatives being delivered with our health partners.



In respect of Voluntary Aided Schools the governing body of the school determines admission arrangements. For Academies and Free Schools, the relevant Academy Trust is the Admission Authority. Each individual Admissions Authority applies its own oversubscription criteria to applications and determines which applicants to offer places to.

Applications for Thurrock Schools are made via the co-ordinated admissions process which is administered by the Council.

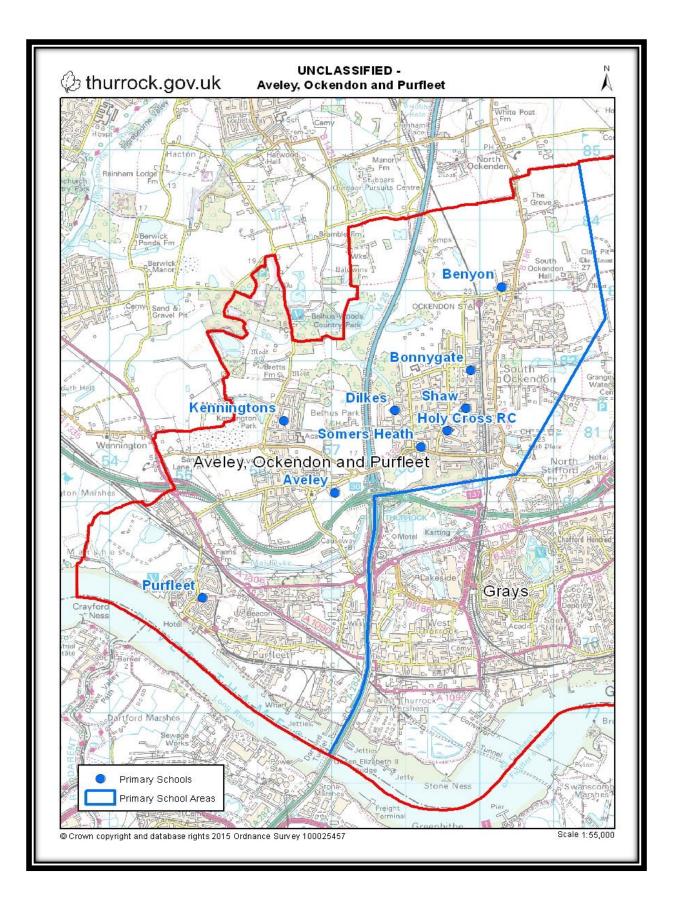
Pupil place projections for each of the planning areas are set out in the following pages.

Reception intake September 2019 was the first year of our highest birth rate, therefore it is predicted that the next three years will show an increase in a reception intake and subsequent year groups.

The whole school projections for each primary school planning area have been calculated using birth data which in recent years was showing an increase five years later when pupils reach school age. These are projected to calculate reception numbers along with the actual number of children on roll in the schools in the October 2019 census, adding the pupil yield from housing developments and then adding an additional element of places to cater for in-year admissions. This degree of additional places is required to enable schools to absorb the number of pupils we anticipate will arrive in Thurrock from elsewhere in the UK and abroad in the September 2020/21 academic year and beyond. The impact of inward migration will be closely monitored and forecasts adjusted accordingly.

Full details of the methodology used to determine the pupil place forecasts for the primary phase are set out in Annex 1.

Primary Forecast Summary

Reception intake September 2019 will be the first year of our highest birth rate, therefore it is predicted that the next 3 years will show an increase in a reception intake and subsequent year groups.

The pressure in the primary phase is being managed and will continue to be regularly monitored closely. The inward migration experienced in recent years had a more significant impact on primary places than secondary places. This may have been because we had capacity in our secondary schools which could absorb the newcomers or it may be that the families arriving in Thurrock had younger children.

Thurrock Primary whole school numbers have increased by 20% since Autumn 2012 which equates to a 2,908 pupil increase. However, the autumn school census for October 2018 and 2019 is showing a significant decrease in the amount of extra primary pupils when compared to the last five years.




SECONDARY FORECASTS

The primary increase is becoming noticeable when pupils are moving into Year 7 and beyond.

Whole school forecasts for each secondary planning area has been calculated using formulae to calculate the transition rate from year 6 to year 7 and the current numbers on roll in schools on the census data from October 2019 and by also adding the pupil yield from any developments and then adding an additional element of places to cater for inyear admissions. This degree of additional places is required to enable schools to absorb the number of pupils we anticipate will arrive in Thurrock from elsewhere in the UK and abroad in the September 2020/21 academic year and beyond. The impact of inward migration will be closely monitored and forecasts adjusted accordingly.

Full details of the methodology used to determine the pupil place forecasts for the secondary phase are set out in Annex 1.

Thames Park Free School and Orsett Heath Free School will open in September 2020. Each school will open to 120 pupils at each site. These sites are temporary whilst their new permanent sites are under construction. This will affect the Secondary year 7 forecast and those pupil admission numbers will not be included until next year's Pupil Place Plan.





The above forecasts include the child yield exceeding 20 pupils from the following developments at: Land adjacent St Clere's School, railway line and Butts Lane, and proposed developments at adjacent to railway line, Manorway and West of Victoria Road and Bata field land adjacent Bata Avenue and to rear of 201 to 251 Princess Margaret Road.

Secondary Forecast Summary

With the number of primary pupils moving into the secondary sector the demand for secondary places is increasing and will continue to do so over the next few years.

Two new Free Schools will open in temporary accommodation from September 2020 with initially a total of 240 places across both schools.



COUNCIL WIDE ISSUES

The two main factors for pupil increases in both the primary and secondary phases are the increase in birth rate and the amount of in-year applications. The table below details the increases of in-year applications outside the normal admission rounds.

Planning for the children arriving in Thurrock is difficult as we do not know who they are, how old they are, and therefore, which year groups they will apply for until they make contact with School Admissions. Some may require Reception and Year 7 places, but many will require places in other year groups. This introduces the potential of bulge classes in year groups other than Reception and Year 7 as we have experienced in recent years.

With the unpredictable demand for places from outside of Thurrock an additional element of pupil places has been added to each planning area within Thurrock.

ANNEX 1: PUPIL PLACE FORECASTING METHODOLOGY

The statutory obligation for all local Councils is to provide sufficient school places. Thurrock Council regularly reviews all data, trends and builds a robust analysis of pupil planning to ensure a place for all pupils that live in Thurrock either at normal admission rounds or the unforeseen "in-year" admissions.

Thurrock experiences high levels of in-year applications which has put pressure on school places but with the excellent relationships we have with our Schools and Academies, Thurrock Council has been able to continue to meet this demand.

Primary Forecasts

Thurrock Council uses live birth data provided by the National Health Service which forms the basis of calculating the place requirements four years later. This data contains post codes where the child lives which are then allocated to the nearest school in that area to calculate places required in that schools planning area.

Whole school forecasts are based on pupil census data; this provides actual pupil numbers in each year group. The number of children calculated from any building development is added to this to then calculate the number of school places required. An element of additional places is then added to cater for in-year admissions.

The building developments which produce over 20 pupils are taken into consideration in this edition of the PPP document and are listed under each planning area.

There is a project team made up of officers from various departments within the Council that play a part in PPP that meet monthly to review forecasts and any emerging issues. This allows the Council to be proactive in taking any necessary action to meet growing pressures for school places.

Secondary Forecasts

With the high level of primary school places we have we know that these will feed through to our secondary schools. When calculating year 7 forecasts we use existing primary numbers. Using trend data we have used a transfer rate of 92%, meaning 8% of our children go outside of the Thurrock area. Thurrock has no secondary provision for Catholic boys who tend to move out of the area to attend a Catholic secondary school.

The Year 7 forecasts in this document were arrived at by examining the conversion rate from Year 6 to Year 7 for the last three years. This is the number of Thurrock Year 6 pupils who went on to become Year 7 students.

Having established the predicted number of Year 7 students for each school, we then address the child yield from housing developments.



We know the predicted number of children in each area that are likely to arise from developments but we cannot know how old they will be or which year group they will require. We therefore assume that some of the children generated by new developments will require primary places and some secondary places.

A number of places are therefore added to the whole school predictions for both primary and secondary at the schools in the areas where the development is due to take place. If a major development falls between two or more schools the child yield is divided between the schools.

Migration

Thurrock is still experiencing increases in the number of children applying for a school place "In Year". These arrivals during the academic year are difficult to manage as we do not know how many of each age group will arrive. The extent of inward migration in recent years indicates that 5% of school places are required in the primary phase and 3% are required in the secondary phase to ensure that the new arrivals can be accommodated.

The forecasts are not constrained by the physical accommodation available in the schools in the planning area and therefore indicate where pressure on places is likely to arise.

Pupil Migration

Thurrock is a net exporter of pupils. The numbers both in and out of Thurrock for receptions and year 7 are listed below. The percentages listed are comparing these numbers against September 2019 actual on time applications numbers for reception and Year 7. These numbers only relate to the normal admission round.



Primary

17 children are expected to come in to the LA +.5% by September 2020

77 children expected to go outside of the LA -3% by September 2020

Secondary

51 children are expected to come in to the LA +2.3% by September 2020

251 children are expected to go outside of the LA - 10.2% by September 2020

ANNEX 2: SPECIAL EDUCATIONAL NEEDS AND DISABILITY (SEND)

An education, health and care (EHC) plan is for children and young people aged up to 25 who need more support than is available through special educational needs support.

EHC plans identify educational, health and social needs and set out the additional support to meet those needs.

The Council has two special schools in the borough

Beacon Hill Academy is a special school in South Ockendon for pupils who have severe and complex learning difficulties. Beacon Hill Post 16 provision caters for students with severe and profound and multiple learning difficulties from 16 to 19. This provision is located on the shared site with Treetops School in Grays. Students follow a personalised, accredited curriculum which promotes independence and transition to lifelong learning in the community.

Treetops School is a day special school academy in Grays for pupils between the ages of 3 and 19. The school caters for children and young people with moderate learning difficulties and Autism.

A new Special Free School has been agreed by the Education Funding Agency and is in development. The school will be located on a site adjacent to the existing Treetops School. The new Treetops Academy is planned to open in the academic year 2021/22.

The numbers of commissioned places in the Special Schools and Resource Bases are agreed between the Council and the schools on an annual basis. There is potential opportunity for additional places to be commissioned by the local authority as required and where possible during the academic year.

ANNEX 3: PROVISION FOR PUPILS OUT OF SCHOOL

Thurrock has developed two new Primary Inclusion Bases for pupils who have been permanently excluded or are at risk of permanent exclusion to provide direct support for these pupils and to support their re-integration into mainstream school. The two Inclusion Bases are at East Tilbury Primary School and Thameside Primary School, both of which are Primary Academies part of the Osborne Multi Academy Trust.

The Olive Alternative Provision Academy based in Tilbury provides a secondary offer for pupils because of exclusion, illness or other reasons, would not otherwise receive a suitable education. The service provides a range of different interventions to support young people to reengage with mainstream provision.

Admission to the service is by referral only. All referrals are made via the Council's Access and Inclusion Service.

ANNEX 4: POST 16 PROVISION

The 2008 Education Act raised the age of participation for young people in England. Those born on or after 1st September 1997 must remain in some form of education or training until their 18th birthday. This may be:

- full time education at school or college,
- an apprenticeship or traineeship,
- part-time education or training as well as being employed, self-employed or volunteering for 20 hours per week or more.

Thurrock Council works closely in partnership with schools and colleges and other providers to plan provision for post 16 education and training. Young people can pursue a wide range of both academic and vocational courses in a range of settings.

Five secondary schools in Thurrock currently offer post 16 education; Gable Hall, Hassenbrook and St Clere's schools form the Stanford and Corringham 6th Form consortium and between them provide a range of academic and vocational courses.

Harris Academy Ockendon Studio School and 6th form is a 14 to 19 school offering a range of academic qualifications in addition to work based training. Applications for work based training places in the Studio School should be made via the Council's school admissions team. There are currently 75 places in the Studio School.

Harris Academy Chafford Hundred and Harris Riverside offers a 6th form provision which has a range of academic and vocational opportunities for young people, information on all the courses is available via the schools website.





Executive Summary

This report outlines Thurrock's Annual Childcare Sufficiency Assessment 2020.

This report is part of the statutory duty as set out in the Childcare Act 2006 which states Local Authorities need to ensure that we are meeting the requirements of early years entitlement with due regard to planning and growth across the Local Authority.

It recognises the regeneration opportunities locally and will look to support some of the national drivers around early years education.

Thurrock Council will continue to:-

- a. To support further early years & childcare development across the borough where re-generation and new housing is taking place
- b.To consider early education future needs before decisions are taken in relation to capital assets across the Local Authority
- c.To support sessional providers to offer, or access wrap around care in partnership, for working parents
- d.To encourage providers, including schools, to participate in the 30 hours entitlement offer to enable more working parents to access their full entitlement.
- 1. **RECOMMENDATION**

1.1 That Children's Services O&S note the Annual Childcare Sufficiency Assessment 2020.

2. Introduction and Background:

Local Policy Context

The Annual Assessment links with the following Council vision and priorities:-

Vision- An ambitious and collaborative community which is proud of its heritage and excited by its diverse opportunities and future.

Priorities-

- 1. People a borough where people of all ages are proud to work and play, live and stay
- 2. Place a heritage-rich borough which is ambitious for its future
- 3. Prosperity a borough which enables everyone to achieve their aspirations

National Policy

Thurrock has been working closely with its early years providers to ensure we can support vulnerable 2 year olds into early education. Thurrock was above the national average for 2 year old take up, at 71% as at January census date 2020, (England 69%) and our communication strategy encourages eligible parents to take up the 2 year old offer.

Thurrock continues to support providers in offering 30 hours of childcare for three and four year olds of working parents, ensuring that we have the appropriate childcare pathways including wrap around care for both early years children, and as they progress to school. This will be critical to the success of encouraging residents to take advantage of the local job opportunities.

Relating this back to our Annual Assessment, we recognise that this has the potential to impact on the places that will be available to 2 year olds across Thurrock. The Childcare Sufficiency Officer is working closely with early years providers to ensure that we can meet local demand for both 2, 3 and 4 year old provision.

Current Support to Early Years Providers from School Effectiveness Team:-

- Support pathways for new early years providers
- Visits to local sites (temporarily suspended due to COVID19) to support early years providers
- Liaison with planning department and assets team
- Monitoring new planning applications to ensure early years provision is included in new development as and when required

• We also appreciate councillor support in including early years education and childcare in any new strategic developments

3. Issues, Options and Analysis of Options

4. Reasons for Recommendation

The reason for the recommendation is that the Department for Education expect us to inform elected members about childcare sufficiency within our borough. This is because The Childcare Act 2006 places a duty on local authorities to make sure that there are enough childcare places within its locality for working parents or for parents who are studying or training for employment, for children aged 0 to 14 (or up to 18 for disabled children). The Childcare Sufficiency Report is a statutory report that must be published on our website and updated annually.

5. Consultation (including Overview and Scrutiny, if applicable)

Future consultation will take place with parents to ensure we have the voice of parents/carers included in any requirements for early education opportunities.

1. Overall assessment and summary

Thurrock Council is required by law to 'report annually to elected council members on how they are meeting their duty to secure sufficient childcare, and make this report available and accessible to parents'. The Council has prepared this report in order to meet this duty¹.

Having sufficient childcare means that families are able to find childcare that meets their child's learning needs and enables parents to make a real choice about work and training. This applies to all children from birth to age 14, and to children with disabilities. Sufficiency is assessed for different groups, rather than for all children in the local authority.

We use information about childcare sufficiency to plan our work supporting the local childcare economy.'

Overall sufficiency in our area

With the National Census being undertaken in 2021, this will give an opportunity to gain ward level population of children broken down into ages to compare with ward level childcare places.

2 year old Entitlement

There are currently sufficient 2 year entitlement places offered by Thurrock childcare providers. The providers understand the importance of the two year entitlement and what it offers to the most disadvantaged children in Thurrock, enabling them to thrive and achieve, as their peers.

2 year entitlement access, especially in the summer term, can be limited due to parents wishing to stay on waiting lists for their preferred provider, despite places available with other suitable, quality providers.

Universal Entitlement - All 3 & 4 year olds.

We have not received any parental feedback that parents cannot gain a places for their child's universal entitlement. There still are parents who do not wish their child to access early years education and childcare, by exercising their right to choose for their child not to participate in this non-statutory offer.

30 Hours Entitlement for children of working parents

The access to the additional 15 hours of entitlement funded hours for working parents of 3 & 4 year olds, pre-COVID 19 is on an upward trend.

Schools are slower to offer the 30 hours for working parents. The Council is hopeful to have some advocates to encourage other school early years providers to participate in this offer.

¹ Statutory guidance on Early Education and Childcare, effective from 1 September 2018. The wording of the 2014 statutory guidance, effective until this date, is identical.

With the expected growth of residential housing particularly in Chadwell St Mary, Corringham, Fobbing, East Tilbury and Orsett wards in the next 5 years, and strategic development around the Lakeside/Purfleet areas, it is imperative that early years education and childcare places out of school wrap around and holiday care, are all considered alongside primary and secondary pupil places for working parents and to meet the Council's sufficiency obligations.

In some areas of Thurrock we have limited atypical hours to offer parents. The local regional shopping centre is open seven days a week, opening as early as 8.00am on some days, and closing as late as 10.00pm. There is scope for supporting these parents to access work, particularly if they have no wider family or friends to help out. Other local employers offer shift or weekend work, which are based in Thurrock, who offer parents employment opportunities.

The majority of schools now offer at least a breakfast club, although this tends to be for the reception age children upwards, despite offering nursery provision. This may be a cultural mind-set that teachers do not participate in the classroom before or beyond the traditional school day. The availability of appropriate staff outside this core time is challenging to some, while others embrace the challenge to overcome the barriers for parents to find suitable childcare to enable access to work or training.

Some areas of Thurrock, such as Aveley Village, do not have access to after school/holiday provision other than limited childminder places. Anecdotally, it has been reported that parents in Aveley Village who work, or are in full time training or education, choose their primary school with this in mind. It would be advisable that any childcare provider who intends to develop an out of school provision in such areas liaise with their local school to determine demand for this type of provision.

Most childminders offer the wrap around care to the school day where their capacity permits, however, some childminders prefer not to offer holiday childcare if they are caring for their own children, particularly if their own children are older.

Most childcare providers in Thurrock practice inclusion in their practice, however, the barrier still remains in some instances, particularly with providers offering a limited number of places where additional support is necessary, which may impact on care and learning, given to other children in their provision.

We are currently exploring strategies to assist working parents of disabled children to access out of school provision, while alleviating additional demands on parents and providers.

Thurrock Council will continue:

- 1.1 To support further early years & childcare development across the borough where re-generation and new housing is taking place.
- 1.2 To consider early education future needs before decision are taken in relation to capital assets across the Local Authority

- 1.3 To support sessional providers to offer, or access wrap around care in partnership, for working parents
- 1.4 To encourage providers including schools to participate in the 30 hours entitlement offer to enable more working parents to access their full entitlement.

Children's needs change over time and are identified at different ages. Among the youngest children, SEND may only be identified when they start in childcare or school, and it can take some time from problems being identified to an EHC plan being issued. 4. Funded early education

Introduction to funded early education

Some children are entitled to free childcare, funded by the government. These entitlements are for minimum of 38 weeks per year.

- All children aged 3 and 4 are entitled to 15 hours per week until they start reception class in school
- Children aged 3 and 4, where both parents are working or from lone parent families where that parent is working, are entitled to 30 hours per week until they start reception class in school⁴
- Children aged 2 whose families receive certain benefits (including low income families in receipt of in-work benefits), or those who meet additional non-economic criteria, are entitled to 15 hours per week. Nationally, about 40% of 2 year olds are entitled to this offer, but the proportion varies by area.

Parents do not have to use all the hours of their funded entitlement. They may choose to split them between providers. With the agreement of their provider, parents may also spread them across the year – for example, rather than taking 15 hours for 38 weeks a year they could take just under 12 hours for 48 weeks a year.

Supply of early education and childcare places entitlement places

In total, there are **196** childcare providers in our local authority, offering a maximum of **3676** early years early education and childcare entitlement places:

In our local authority, 28.16 % of 2 year olds were entitled to funded early education as at 31 March 2020.

From Summer Term 2019 to end of Spring Term 2020 a total of 1786 eligible children accessed 2 year old entitlement funded places.

3 and 4 year old funded entitlement applications

Parents who think they are entitled to a 30 hour extended hours place apply for this online through the Government's Childcare Support website. The same website is used to apply for tax free childcare and parents can apply for either or both. If a parent is eligible, the system creates a code which they can use with their chosen childcare provider. If they are ineligible, they will still be entitled to the universal 15 hours of early education and childcare.

The number of 3 & 4 year old children eligible for a 30 hour place as at end of Spring Term, 31 March 2020 was 1163 of those 79.62% accessed a place*. *This data is based on live data Thurrock Council for Spring Term 2019.

COVID 19 - Parents have had codes agreed but due to the pandemic have chosen to not send their child to their placement which has had an effect on the numbers of children in a placement. Some of placements also closed due to the pandemic.

This last term it has been agreed to take codes that were submitted late. This applied in particular to our critical workers and affected our data as we paid some codes which were very late.

In addition to this, to minimise the risk to our placements we agreed to match funding from the previous term so no placement had a reduction in funding.

Providers offering funded early education places

Providers are paid directly by government for delivering funded early education. They are not required to offer them to parents, but of course parents may choose to use a different provider if they do not. Some providers offer a restricted number of funded places.

Both fall within the West Thurrock South Stifford ward, however the Purfleet Locality requires its designated early years provision, due to the industrial sprawl between West Thurrock and Purfleet.

Supporting economic wellbeing

Accessible and affordable childcare supports families to work and good quality early years experience supports children's cognitive and emotional development, aiding transition between home and the early years setting and improving school readiness. For some families, the need for good quality, accessible and affordable childcare is at

least partially satisfied by informal childcare arrangements such as with family and friends, but for no means all. Single parent households and families without established social structures may not have access to informal childcare. For those that do, informal childcare may not support the social and cognitive outcomes associated with good quality formal early years development and learning.

Supporting children to achieve their potential

In 2008, a Joseph Rowntree report concluded that appropriate childcare could move between 0.17% and 50% of children out of poverty. A 2012 DfE research report evidenced that early education starting at an early age had a direct impact on the attainment of children.

The body of evidence is large and growing; a quality early years experience can boost children's all-round development, and is particular beneficial for least advantaged children.

The economy

From April 2019 to March 2020, 11.3% of households in Thurrock were defined as workless, this compares to 11.9% in the East region and 13.9% nationally. Employment levels are slightly higher when compared to the regional and national average figure for employment.

7. Quality of childcare in our area

Ofsted inspection grades

All childcare providers must register with and be inspected by Ofsted, who give them an overall grade for the quality of their provision. Childminders and private and voluntary providers are on the Early Years Register, and schools and standalone maintained nursery schools are on the Schools register. The grades for both registers are equivalent. Schools with nurseries have an overall inspection grade for the whole school and most also have a separate early years grade.

Both schools and early years providers have four possible Ofsted grades: 'outstanding', 'good', 'requires improvement', and 'inadequate'.⁶ Some providers are still awaiting their first full inspection. These providers are excluded from our calculation.

Nursery classes in independent schools do not generally have an Ofsted grade.



Sufficiency & COVID19



Childcare became an important part of the critical worker support during this time, while we must acknowledge the tremendous loss of life and the selfless workers who carried the country through this worrying time. During the whole period of the pandemic, this data represents sufficient places were available to match demand.

The graph below demonstrates the childcare provision in Thurrock prior to the COVID19 Lockdown.




The information on the following page is based on data collected via telephone from childcare settings during the COVID19 outbreak in Summer Term 2020 for Department for Education (DfE), reported as the dates indicated. The lowest number of childcare settings open fell over the two weeks following the Easter weekend, and was due to the fall in childminder provision and group based early years settings open during and immediately after the Easter Holiday. It was at this time the school based early year's provider data started to be collected.



The information below shows a peak average of 151 providers closed during the six weeks commencing 30 April to 28 May 2020. From that point the data demonstrates the return of settings opening.



The information on the following page demonstrates the breakdown of children accessing provision in regards to children of critical workers and vulnerable children against the overall total of those accessing. For the majority of the pandemic, vulnerable children were less likely to be accessing provision. It's not until the beginning of June we see uptake of vulnerable children places grow alongside children of critical workers.

Executive Summary

This report outlines the work that has been undertaken by Inspire in the academic year 2019-2020. It provides an overview of the work against the key services in Inspire.

1. Recommendation(s)

- 1.1 O&S to scrutinise the work that has been undertaken by Inspire in 2019-2020 and offer challenge and support.
- 1.2 O&S to consider how they could support the various Inspire services, especially when faced with the challenges of the pandemic.

2. Introduction and Background

2.1 This report sets out the work of Inspire Your Future which is our integrated Youth Hub working with young people 16-19 and up to 25 with additional needs. As we continue to navigate a very difficult landscape due to Covid 19 we cannot underestimate the significant challenges this presents to our young people 16-25 around gaining employment. We recognise that youth unemployment has increased significantly and that nationally the pandemic has had a disproportionate impact on this age group. Clearly our focus has to be on supporting these young people going forward. We have a strong track record around delivery of programmes, evidenced by our successful On Track Thurrock programme which has provided bespoke tailored programmes to support skills development. However this needs to work in conjunction with our local businesses to identify the vacancies and employment opportunities going forward. The Adult Community College will also provide support for this on our programme of continual learning.

- 2.2 Thurrock has maintained its strong commitment to ensuring that young people can access an integrated youth offer which incorporates the following:-
 - Inspire Careers focuses on supporting Thurrock young people in the Skills agenda by providing a high quality careers service which is Matrix (the national quality assurance assessment) it offers impartial careers advice to young people aged 13-18 and up to 25 with Special Education Needs and Disabilities (SEND).
 - Inspire Skills builds on developing employability skills of Thurrock young people by bringing the world of education to the world of work, this is undertaken via our Careers Enterprise work which links business to schools to support with careers information advice and guidance.
 - Inspire Head Start Housing provides suitable accommodation for care leavers.
 - Inspire Return Home Interview service provides opportunities for missing young people to talk about who, what, where and when to enable coherent, intelligence led interventions.
 - Inspire Youth and Outdoor Team develops young people's confidence by using informal education thus preparing our young people to be resilient as they enter the world of work.
 - Inspire Post 16 SEND works closely with young people with SEND to enable them to access the educational, training and employment opportunities available in Thurrock and looks to provide opportunities for SEND young people of the borough.
- 2.3 Inspire Thurrock Careers (ITC) work effectively to deliver Careers, Education, Information, Advice and Guidance (CEIAG) to schools in Thurrock under the Section 42A and 45A of The Education Act 1997. Additionally, ITC provide impartial CEIAG to schools as a traded service under the duties of The Education Act 2011. Our statutory responsibilities derive from the 2008 Education and Skills Act (ESA 2008) to make available such services as it considers appropriate to encourage, enable or assist the effective participation in education or training and to collect information about young people in their area in order to identify those who are not participating, or who are at risk of not doing so, and to target resources on those who need them most.
- 2.4 In providing this duty Inspire Thurrock Careers have successfully kept the NEET and Unknown 16-18 year old figure at 2.5% at end September (compared with 6.2% nationally and 7% statistical neighbours). All three annual reports to Department for Education (Activity Survey, Intended Destinations and September Guarantee) had 100% completion satisfying our statutory duty on tracking and encouraging participation in EET whilst making sure that every single young person in Thurrock had an offer of an education place in September 2020. Thurrock is placed 4th Local Authority in the

country for its combined NEET and Unknown figure, which is a fantastic achievement.

- 2.5 ITC has successfully applied and awarded external funding with National Apprenticeship Service, Make Happen to run programmes encouraging young people into HE, apprenticeships, delivering inspiring apprenticeship and HE awareness assemblies and apprenticeship application workshops. Much of this work due to Covid has been undertaken on digital platforms engagement figures are being collated to provide evidence of learning from the sessions which will used to inform the future development of the programmes.
- 2.6 During the Covid-19 pandemic ITC worked closely with our Year 11 and Year 13 students by contacting our young people on an individual basis and creating a Results Day 2020 Aftercare Support Guide which was very well received by all students.
- 2.7 ITC are intensively working with NEET LAC young people by providing weekly innovative Employability workshops, participating in DofE scheme and Prince's Trust teams. This links with our work around Headstart Housing which provide good quality accommodation for our care leavers.
- 2.8 During Covid-19 ITC has provided careers and employability advice from the Inspire Youth Hub, virtually from March 2020 to August 2020, and a blended deliver including some physical meetings from September 2020 ensuring that the most vulnerable are provided with tailored support to enter EET.
- 2.9 Inspire Head Start Housing is responsible for the provision of suitable accommodation for care leavers. Head Start Housing's remit has extended to include Sanctuary Housing which provides hostel accommodation, as well as provision for Care leavers with special educational needs and or disabilities and a mental health condition(s).
- 2.10 Head Start and the Housing Directorate has identified 3 properties to purchase and modify, for exclusive use by care leavers. The first property, in Grays, should be ready for tenants to move in early November. The second property, in South Ockendon, should be ready for tenants to move in early January 2021.
- 2.11 Head Start is working towards all properties having wifi, council tax relief applied, TV licence, a welcome pack, communal cleaning and garden maintenance as standard.
- 2.12 An equitable rent system is being piloted. Care leavers in employment, sharing accommodation with care leavers in receipt of Personal Allowance/Universal Credit, make a contribution towards the cost of their rent.
- 2.13 From November, the School Wellbeing Service will pilot the provision of a therapeutic space for the high level needs care leavers to explore what is

possible and be signposted to services. Inspire Youth Service mentors will offer mentoring to care leavers with lower level needs. Working in partnership cross directorate and with external partners, we are seeking practical, engaging ways to equip young people with skills to be independent.

2.14 Inspire – Return Home Interview service was launched 1 April 2020. The service support young people with return to home interviews. The data outlined below shows the current position after two quarters of reporting:-

- 2.15 Inspire Skills lead on the work of partners to support pathways into employment, e.g. work undertaken with the Local Enterprise Partnership (LEP). Ongoing work with the LEP is gaining momentum; schools have been partnered with Enterprise Advisers whose work will complement the Careers Strategy in each school. Future exciting projects on enhancing collaboration of education with business are underway an example is work around opportunities to work with young people with learning disabilities.
- 2.16 Inspire Skills hosted Opportunity Thurrock October 2019, the largest careers fair in Essex in place for 10 consecutive years, where students from Years 8 to 13, attend the event at the London Cruise Terminal, Tilbury, and have the opportunity to meet over 100 exhibitors and learn about the different career opportunities available across the borough and in the immediate surrounding areas. Businesses exhibit from sectors including: construction, creative and cultural, engineering, hospitality, logistics, public services and retail. Universities and educational establishments also attended the event from across the country to promote their courses and further education offer. Clearly as a result of Covid 19 we have had to consider how to take this work forward we are looking at digital platform to support both leaners and employers to explore work opportunities.
- 2.17 Inspire Youth and Outdoor Education Team have adapted their offer in 2019-2020, principally as a result of Covid-19 the team have delivered extensive detached work in Grays, Tilbury, Ockendon and Purfleet, focusing on providing mentoring and well-being support to Thurrock young people. Since the COVID lockdown the team have engaged with over 1500 young people and their families in a range of activities from our virtual youth programme to learning to sail. The youth team provide a virtual delivery timetable to Thurrock young people which was well received and supports them to stay connected and less isolated.
- 2.18 Inspire Prince's Trust continues to deliver the Team programmes even during lockdown; teams that are run post Covid-19 are smaller in size , focus

on young people with SEND and provide a blended delivery programme in line with national guidance. Young people on the programme feel supported and grow in confidence.

- 2.19 Inspire DofE Team have been supporting schools to deliver awards to the students. All young people will have the opportunity to either gain a certificate of achievement or alternatively complete the full award next year. The team are engaging with the National Autistic Society to support them in achieving their Bronze award, and have recently reached out to SENCOs in school to encourage a more inclusive offer.
- 2.20 Inspire -Youth Cabinet have a blended learning approach with a combination of virtual and face to face meetings each month. Focussing on our SEND Young people, the Cabinet are creating workshops and Q&A sessions around youth employment to raise awareness of the barriers SEND face in everyday life in particular with employment.
- 2.21 Inspire Grangewaters offer a range of outdoor learning opportunities to Thurrock residents. The summer programme was extremely busy. The schools based programme which include alternative education has continued over the summer term and into the autumn. A key area of development has been around SEND provision – this has been designed with young people and is looking to address the need to provide more post 16 provision for this cohort of learners.
- 2.22 During the complex and rapidly changing situation of Covid-19, Inspire have supported Thurrock young people by understanding the challenges facing young people and schools, ensure that we are providing them with the necessary resources to support and tackle youth unemployment. Inspire has joined the National Youth Employment Forum enabling Inspire to be at the forefront of youth developments in the country. This involvement has led to Inspire progressing with the Government-led Kickstart flagship programme providing employment opportunities to Thurrock young people. This scheme will come into effect in November 2020 and will begin to tackle youth unemployment in the borough which has seen an increase due to the pandemic.

3. Issues, Options and Analysis of Options

3.1 The Council has a statutory duty to track and provide educational and training opportunities for its young people and as such Inspire are working on ensuring that the whole system approach is taken to ensure young people are supported, have the best possible careers guidance which is inspirational and aspirational and that they are developing their skills necessary to prepare them for the world of work.

4. Reasons for Recommendation

4.1 Children's Overview and Scrutiny have a clear and accountable governance responsibility around supporting children and young people – the report will enable committee members to be reassured of the progress of Inspire in delivering on the objectives of the Local Authority and provide scrutiny. We would ask committee members to consider how they would like us report back on progress in the future.
