SALE OF THE GATEWAY SOUTH SITE (THE FORMER ST.CHAD'S SITE)

Purpose: To seek urgent delegated decision for the sale of the former St. Chad's

site.

Wards affected: Tilbury Key decision: Yes

1. **RECOMMENDATIONS**:

1.1 That the Leader of the Council approve the sale of the Gateway South site (former known as the St. Chad's School site).

2. BACKGROUND:

- 2.1 The Site is currently occupied by the Gateway Academy and will become surplus to requirements when the Academy move to the new building in Marshfoot Road which is anticipated in April 2008.
- 2.2 Cabinet agreed on 22 March 2006 that the Head of Resources (CEF), on the advice of the Head of Legal Services, be authorised to agree the arrangements to procure the new build with the Department for Education and Skills (DfES). The report in sections 3.6 and 4.45 refers to the sale of the former St. Chad's site.
- 2.3 The intention as outlined in the Cabinet report of 22 March 2006 was to gain funding towards the whole Academy package by disposing of the built footprint of the school. However, there is no Cabinet resolution about the sale.

- 2.4 The Council's Constitutions under, Part 3.8: Cabinet Members: Portfolios and scheme of Delegation, Part B The Leader Delegated Powers states, "Urgent decisions
 - a) To make any decision on an Executive Function that would be a decision for the Cabinet or a Cabinet committee to take, where the decision is urgent and:
 - i. A Cabinet Meeting is not scheduled within 15 Days; and
 - ii. The Deputy Leader and the relevant Cabinet Member(s) has/have been consulted: and
 - iii. The relevant procedure has been followed."
- 2.5 The conditions outlined above and the relevant procedure is set out in Part 2.1 Rule 10 Key Decisions Special Urgency, have and will be satisfied through the circulation of this report.
- 2.6 There is a need to proceed urgently with the sale as the prospective buyer is looking to withdraw from the purchase unless the exchange of contracts happens immediately. If this sale falls through there is no guarantee or indication that this price will be achieved in the future and the Council could therefore lose the receipt.
- 2.7 In order for the exchange of contracts to take place formal approval for the sale must be given. The Leader of the Council is therefore requested to approve the sale of the Gateway Academy south site using delegated powers set out in Thurrock Council's Constitution.
