**Purpose of Report:** To consider the proposal to install a bus stop pole, timetable case and flag on the highway outside of no. 8 – 10 Long Lane, Grays

### **EXECUTIVE SUMMARY**

To consider the proposal to install a bus stop pole, timetable case and flag on the highway outside of no. 8 – 10 Long Lane, Grays

#### 1. RECOMMENDATIONS:

1.1 To approve the request for a new bus stop pole, timetable case and flag to be installed on the highway outside of no. 8 – 10 Long Lane, Grays

#### 2. INTRODUCTION AND BACKGROUND:

- 2.1 A consultation has recently been carried out with local residents living in the vicinity of the proposed site to obtain their views on the proposal to install a bus stop pole outside of no. 8 10 Long Lane, Grays
- 2.2 A request was made by local residents to provide an additional stop outside of no. 8 10 Long Lane, Grays in order to pick up passengers waiting for the public bus services safely.

2.3 At present the following services serve Long Lane, Grays

•	25	Lakeside to Stifford Clays	Operated by Ensign Buses
•	88	Lakeside to Stifford Clays	Operated by Ensign Buses
•	201	Lakeside to Basildon	Operated by Arriva Southern Counties
	269	Grays to Brentwood	Operated by Amber Coaches Ltd

2.4 A consultation letter was sent out to local residents and ward members to see if they had any objections to the proposed bus stop. In total 1 objection was received

#### 3. ISSUES AND/OR OPTIONS:

- 3.1 If the bus stop were to be installed outside no.8 10 Long Lane then it is believed that the bus stop would greatly benefit local residents as currently the nearest bus stop is approximately over 200 yards further along Long Lane. Given that many residents living in and around Long Lane are elderly, it is considered that if a new bus stop were to be installed outside no.8 10 Long Lane this would then reduce the distance that these residents would have to travel to reach the bus stop in order to use the local bus service.
- 3.2 If a bus stop were to be installed this would not have a detrimental effect on the local residents. In addition it has been determined that this bus stop would not impact on the local residents ability to enter and exit their driveways by their own vehicles.
- 3.3 The site identified has been chosen due to its close proximity to the surrounding residential area. If the site for the bus stop were to be relocated further along Long Lane, Grays it is believed that residents would have to walk further away from the residential area to reach the bus stop and therefore the bus stop will be underused.
- 3.4 The site will also require a footpath and hardstanding area so that elderly or infirm passengers or those with wheelchairs and pushchairs can access the stop safely during inclement weather. A quotation for a footpath and hardstanding has been sought from the Highways department along with the quote for the installation of the bus stop pole itself.
- 3.5 The proposed site for the new bus stop is not near any dropped kerbs or driveways so therefore should not impact on resident's walking ability to enter/exit their property.
- 3.6 The proposed bus stop would be installed on the kerb on the edge of the highway which would be of some distance from the front gardens and hedgerows surrounding the properties behind. Therefore the passengers waiting at the bus stop would not invade the privacy of the properties directly behind the bus stop as the distance from the proposed bus stop location and the front windows of the properties behind would be too great for any person to cause any disturbance to the residents.

- 3.7 This site would compliment the stop which is placed in the opposite direction and despite initially receiving some concerns from residents, has been successfully implemented without any further repercussions being raised.
- 3.8 Funding is available in the current transport programme. It is estimated that this new bus stop would cost a maximum total of £3,500 for the pole, flag and timetable case to be installed along with hardstanding and a 1.2 m wide by 5m long footpath for passengers to traverse the grass verge from the pavement to the kerbside and bus stop safely.
- 4. CONSULTATION (including Overview and Scrutiny, if applicable)
- 4.1 The consultation was mainly conducted by Councillor A Gaywood who distributed letters and liaised with local residents directly to ascertain their views concerning the proposed installation of the bus stop at this location. The returns of the consultation provided 1 objection. This item has not been to overview and scrutiny committee
- 4.2 Ward members were consulted along with the Portfolio Holder for Regeneration, Highways and Transportation. A response was received from Councillor A Gaywood who has requested that if approval is granted for the bus stop to be installed then this should be kept under review for a period of time to ascertain if the comments from the objector are borne out.
