Thank you madam mayor. Thank you councillor for your question. Lots of residents have raised issues with access to primary care and I know the conservative councillor for Chadwell raised this with me a few weeks ago and in regards to Chadwell surgery. Quite frankly it is struggling with the current climate as you can imagine and wasn't great beforehand. What I have done is I've raised this primary care access issue and a number of recent discussions with health partners including the Thurrock CCG. Most recently I discussed this specifically with Rahul Chaudhari, he is the CCG Director of Primary Care, on Monday 5th July. He advised that primary care is currently experiencing an unprecedented challenge in terms of patient demand plus also staffing capacity challenges as they continue to roll-out the Covid vaccination programme as well as providing the usual care. We suggested that some communications for local residents might be useful, including on alternative sources of care and advice where appropriate including the use of the 111 health scheme which will also allow triage of people as they come through. The current challenges are primary care access have also been discussed at some length at Thurrock Integrated Care Partnership Board in recent weeks and are being picked up by the MSE Health & Care Partnership.

Yes thank you madam mayor and thank you for your reply Councillor Mayes. I am very concerned about access to GPs in Chadwell over the last year there's been at least two cases of elderly residents ending up seriously very seriously near death ill because they could not get treatment from their GP. Chadwell residents have since heard that the opening of the Tilbury integrated medical centre may mean the closure of both Chadwell surgeries. Can you reassure Chadwell residents that the opening of the new Tilbury integrated medical centre will not result in GP surgeries being moved out of Chadwell.

Please will you meet as a matter of urgency to discuss how more immediate improvements to GP services can be made and go back to health partners to gain reassurances that the new Tilbury integrated medical centre will not mean that primary healthcare will be moved further away from Chadwell residents.

Thank you madam mayor, thank you Councillor Muldowney for your question. The pedestrian gates that provide access to the walkways throughout the borough cemeteries have not been locked for several years. Additionally the vehicle gates have also remained unlocked for over 18 months. This has provided access to our cemeteries for those visiting the sites with mobility limitations, with no restrictions on visiting times. It would appear that leaving the vehicle gates open has not attributed to this incident occurring as the pedestrian gates remained open for several years prior to this without any incident. In relation to this particular incident the Police and the officers from the council have been liaising to discuss the matter further and as I said in conversation with the newly elected councillor for Chadwell, just recently, this form of anti-social behaviour is clearly both very unsettling and unacceptable but thankfully it's very rare. Most members of the public are respectful when visiting their loved ones in our cemeteries.

Thank you madam mayor. I would. We've just heard how £109,000 was spent on the bin sites for waste during the bin strike some of that money was spent on security who were there to watch the gates. I think the Council needs to take some responsibility for the security of where our borough's loved ones rest and that make sure they lie in peace. I expect we would all like to leave our houses or car doors unlocked but we know that we can't, the argument that some gates have never been locked doesn't wash, and maybe they haven't but may be now they should. Given the recent problems, at least after dark. If you will not commit to locking the gates at night or providing security will the portfolio holder agree to install CCTV in the cemetery so that the Police might have some hope of catching the culprits in 'future?

Most people when visiting our cemeteries respect these areas. Are considerate to everybody and again I repeat these incidents are pretty rare but should always be condemned.

I was also told that if anti-social behaviour reoccurred the council would be happy to review its decision not to lock the gates so I call on you again please - your willing to spend money watching waste sites, your willing to you know you're willing to not to install CCTV so that the Police can actually have a chance of catching culprits. This was a really really bad act of vandalism and a lot of residents not just in Chadwell but from all around the borough are really upset about this and have been writing to me. Please will you agree to meet with me to see if we can find a way to improve the security not just on Chadwell cemetery but all our cemeteries in the borough?
