The Household Support Fund final notification was received on 22-02-23, for the grant period 2023/24.

The critical timeline is that this funding has been used to provide Free School Meals in the holiday period. The Easter holiday period runs from the 3 April and to enable schools to issue the vouchers a decision is required. Delay will mean that no vouchers can be issued for Free School Meals for the Easter holiday period.

Public expectation is that the HSF will support Free schools meals during the holiday period.

Approval to the full use of funds expediates release of funds to the Essential Living Fund for the immediate benefit of residents.

Cabinet have agreed Option 2 that provides a managed change to distribution of Free School Meals and allows for funds to be directed to the Essential Living Fund that is an application-based system of support.

Executive Summary

In the Autumn statement, to support vulnerable people, the Chancellor announced a further £1bn to enable an extension to the Household Support Fund over 2023/24.

The Household Support Fund should continue to support those most in need and to help with global inflationary challenges and the significantly rising cost of living, particularly those who may not be eligible for the other support.

Energy bills may be of particular concern to low-income households during the period of The Fund and Authorities should prioritise supporting households with the cost of energy. The Fund can also be used to support households with essential costs related to energy, food and water, and with wider essential costs.

Authorities should also consider providing support to disabled people and people with caring responsibilities in their area. These two groups in particular may be facing acute challenges due to the disproportionate impact that rising costs bring for the additional services they need in order to manage their conditions, remain independent and avoid becoming socially isolated.

Authorities must operate at least part of their scheme on an application basis - residents should have the opportunity to come forward to ask for support.

Any change to the use of Free Schools Meals for the distribution of the Household Support Fund, would need careful and early communication to manage expectations.

Recommendation

Member to consider the options presented, with Option 2 providing the balance between Free School Meals and the Essential Living Fund that is an application-based system of support.

2. Introduction and Background

2.1 The objective of The Fund is to provide crisis support to vulnerable households in most need of support to help with significantly rising living costs.

Thurrock's grant allocation for 2023/24 is £2.590m.

Appendix A shows how the Grant has been utilised in 2022/23.

3. Issues, Options and Analysis of Options

3.1 The following options have been developed for Member consideration:

3.2 Free School Meals

Is a means to distribute targeted funding to children with families. Public perception also links holiday Free School Meals to the Household Support Fund. In 2022/23 an average of 8,000 children and young people have benefited from this support in each of the holiday periods.

A. Free School Meals to be paid - All School Holidays

The table below shows the cost implication of providing a payment for each of the holiday periods in 2023/24.

The Easter holiday period would be required to be paid twice in 2023/24. This would utilise 57% of the grant allocation.

B. Free School Meals to be paid – Easter and Summer School Holidays

An option to consider is continuing with the Easter period and making a one-off payment to cover the summer holiday period. This would provide support to families and provide notice to reduce the dependency and expectation. The cost implication is shown below:

C. Free School Meals to be paid – Summer School Holidays only

A further option is to consider only making a one-off payment to cover the summer holiday period. This would reduce the administration on the Local Authority and Schools & Academies. The cost implication depending on the value paid is shown below:

D. No Free School Meals to be paid

The final option is to not distribute any fund through Free School Meals and allow residents to apply to the Essential Living Fund.

In a recent call with the DWP a number of LA's are moving away from FSM or are considering a one-off payment. Initial discussions with Essex CC and Southend suggest all options would be put to Members but feel FSM will still be used in some form.

3.3 Care Leavers – Should future support continue or should those in need be directed to the Essential Living Fund

3.4 Essential Living Fund

The scheme can continue to be expanded to include Utilities and the amount awarded prioritised to Food and Fuel with a 4-week award. Discussions will be held on a monthly basis, to understand take up, to ensure funds are utilised.

The ELF is not restricted and will support the allocation of funds to all residents, deliver on the targeted groups outlined above and the requirement for people to self-refer for emergency help.

Essential Living Fund

The ELF for the period October to March, no restrictions on use of funds, funding was increased to 4-week awards (previously 2-week) for food, fuel, and utilities, with all other goods remaining unchanged. Low-income claimants who site they are struggling will be included in eligibility under HSF funding.

Pensioners

For the period April to October Pensioners has to account for a third of the allocated grant. The Local Council Tax Scheme (LCTS) data was used to identify low-income pensioner households, 3,246 pensioners in receipt of LCTS received £120 per household.
