#### 50. MAYOR'S ANNOUNCEMENTS

Councillor Mrs. Irene Archibald - Died 8 November, 1999

It was with sadness and regret that the Mayor announced the death of Councillor Irene Archibald on 8 November, 1999.

Councillor Irene Archibald had worked very hard for the communities of Thurrock and Basildon, as well as for the Labour Party over many years, before she became a Councillor for the Homesteads Ward on 1st May 1997.

He knew that she was highly regarded by colleagues and by all those who came into contact with her. He would remember her as a kind and considerate person, who went about her work with a quiet and dignified efficiency.

She left her husband Councillor Bill Archibald and family and everyone's thoughts were with them at this difficult time.

Councillors Mrs. Betts, Smith, Gillam and Andrews also spoke of the untimely death of Councillor Mrs. Irene Archibald and of her dedication to the people of Thurrock, and particularly the Homesteads Ward. Her death had been a shock to everyone and she would be sorely missed by the people of Thurrock and colleagues alike.

In tribute and as a mark of respect, the Council meeting stood for a minute silence.

#### **Thurrock Community Chest**

The Mayor was pleased to report that the first of the mini prize draws for the Thurrock Community Chest had now taken place. The prizes had been claimed and the winning tickets returned to the community chest. A little under £5,000 in the fund had come from the draw, with another £5,000 having been raised by voluntary organisations.

#### Torch Light Parade

The Mayor also referred to the Torch Light Parade that had taken place on Saturday 4 December, 1999. Despite the bitterly cold weather, the parade was a huge success. He thanked Joan Kelleher for the idea and her colleagues Kevin Smith and Lesley Chalk for

organising the event. He also thanked the carnival associations and all the other organisations that participated in making the event so successful. The Mayor very much hoped that it would become an annual municipal event.

#### Millennium Ball

The Mayor gave notice that the Millennium Ball would be held on Friday 28th January 2000 at the Civic Hall. Tickets were £10 per person including a buffet and all proceeds would go to the Thurrock Community Chest.

#### Mayor's Banquet

The Mayor's Banquet would be held at the House of Commons on Saturday 8th April 2000 and tickets would be £75 per head. The price included return coach, a tour of parliament, meal and wine. Proceeds would go to the Thurrock Community Chest.

#### Children's Promise

The Mayor urged colleagues and officers to join him and his wife in supporting the Children's Promise appeal by donating their last hours pay for this millennium. The money raised would go to children's charities.

#### 51. PRIDE IN THURROCK'S LAST MILLENNIUM

Jonathan Catton, Heritage and Museum Officer, gave a presentation on Pride in Thurrock's Last Millennium.

He began by taking a heritage route to demonstrate how Thurrock was growing and featuring on the 'map' more often. He referred to how Thurrock had been inhabited from earliest times and went on to list some of the themes that illustrated the diverse history of the Borough. These ranged from the numerous listed buildings and structures to the sites of special scientific interest and the 650 archaeological sites in Thurrock. In addition, he spoke of the local history society and the numerous community organisations that added to the heritage of the Borough.

Mr. Catton spoke of how local folklore was attributed to places in the Borough and of the building of the Dartford River and Tunnel crossings. He also referred to the number of films and television programmes that had been filmed in Thurrock.

A number of famous people had originated in Thurrock, including the earliest named citizens, Mucca and Fobber, from which the place names Mucking and Fobbing had derived and of Henry de Gray, a

577 U20351A.ajs Council: 8 December 1999 French Knight, who purchased Grays Thurrock in 1195 from Issac the Jew. Daniel Defoe, a local brick and tile manufacturer, and the author of 'Robinson Crusoe' lived on the Chadwell-St-Mary marshes and Count Dracula lived in Purfleet for a short while.

Some famous events had also taken place in the Borough, such as Queen Elizabeth I's eve of Armada invasion speech at West Tilbury in 1588 and the first Zeppelin to be shot down, partly by Purfleet Gunners in World War 1, in 1916.

Various philanthropists had funded schools and hospitals in the area, such as William Palmer, John Passmore Edwards and Andrew Carnegie.

Farming, the wool trade, gravel and clay extraction, explosives, chalk and lime extraction, edible oil, margarine, soap, lard and steel drum and shoe production had all contributed to the Borough's industrial heritage. The Grays Co-operative movement and the coming of the railways had also added to this heritage.

Thurrock had many international connections and was the first contact for many Caribbean workers arriving on the 'Windrush' in the early 1960s. Several place names from Thurrock were found across the world and Dutch and Czechoslovakian workers had contributed to the economic viability of Thurrock.

Many residents had lost their lives in both World Wars and conflicts around the world, whilst Thurrock boasted a military set of buildings protecting the capital against river borne attack such as the Tilbury and Coalhouse Forts.

The local government heritage of Thurrock had begun with the Saxon Chafford Hundred and the Barstable Hundred and the Lord of the Manor's right over such things as taxation and having a pillory, ducking stool and whipping post. Parish Councils took over many of these roles, including the ability to employ a Beadle and ale tasters. Eventually Urban District Councils for Purfleet, Grays, Orsett and Tilbury were inaugurated, with the Thurrock Urban District Council being formed in 1936. Borough status was achieved in 1974, and Unitary status in 1998.

He finished by talking briefly about how heritage could help Thurrock pride and that the many historic treasures of the Borough could be used to help promote the economy, education and future well-being of Thurrock.

The Mayor thanked Mr. Catton for his very succinct and interesting presentation. Councillor Andrews also congratulated Mr. Catton on the presentation and suggested that Mr. Catton produce the presentation in booklet form for sale in the Borough.
